

# ShopWorks OffSite V1.0 Customer Software License Agreement

Carefully read all the terms and conditions of this Agreement. The license set forth below is given by ShopWorks, Chantilly, Virginia USA (referred to as "LICENSOR") with respect to a program called ShopWorks OffSite V1.0 Software (referred to as "SOFTWARE").

YOU MAY NOT ASSIGN, SUBLICENSE, RENT, LEASE, CONVEY, OR OTHERWISE TRANSFER, TRANSLATE, CONVERT TO ANOTHER PROGRAMMING LANGUAGE, DECOMPILE OR DISASSEMBLE SUCH PROGRAMS. YOU MAY COPY THE SOFTWARE ONLY FOR BACKUP PURPOSES AS EXPRESSLY PROVIDED BELOW.

1. License: The individual (referred to as "LICENSEE") listed above:

- (a.) has the limited non-exclusive right to use the SOFTWARE on A SINGLE COMPUTER
- (b.) once installed, LICENSEE may not physically transfer the SOFTWARE from one computer system to another unless approved in advance by LICENSOR . LICENSEE may not provide copies of the SOFTWARE to others.
- (c.) License to use SOFTWARE is non-transferable to other individuals, whether they work for company listed above or another company.

2. Copies and Modifications: The SOFTWARE is copyrighted. LICENSEE may make one copy of the SOFTWARE, per month, solely for back-up purposes. LICENSEE may not copy the program except for the back-up copies. Back up copies of SOFTWARE may not be distributed to other individuals or companies without prior written consent from LICENSOR. LICENSEE may not modify the SOFTWARE IN ANY WAY.

3. Confidentiality: The SOFTWARE is protected by international copyright, trade secret and trademark law. By accepting this license, LICENSEE acknowledges that the SOFTWARE is proprietary in nature, and that the SOFTWARE contains valuable confidential information developed or acquired at great expense, including data processing algorithms, innovations and concepts. LICENSEE will not disclose to others or utilize such trade secrets or proprietary information except as provided herein. This obligation shall survive the termination of this Agreement.

4. Term: This license is effective the day SOFTWARE is installed by LICENSEE, a company or employee hired by LICENSEE, or by a ShopWorks technician at the LICENSEE site. Failure to comply with any term of this Agreement may terminate this license upon notice to you in writing. Upon termination, all software copies, CD's and other media must be returned to ShopWorks. ShopWorks may enforce other legal rights if necessary.

5. Limited Warranty and Liability: It is the responsibility of LICENSEE to choose, maintain and match the hardware and software components of the computer system on which SOFTWARE will be used. No implied warranty (or condition) as to the quality or performance of SOFTWARE, including any warranty (or condition) of merchantability or fitness for a particular purpose, is given for SOFTWARE. All such warranties are expressly disclaimed. No other warranty or guarantee given by any person, firm or corporation with respect to SOFTWARE shall bind LICENSOR or anyone else who has been involved in the creation, production or delivery of the program (some States or Provinces do not allow limitations on how long an implied warranty lasts, so the above limitations may not apply to you).

Neither LICENSOR nor any other person, firm or corporation is responsible for the loss of revenue or profits, expense or inconvenience, or for any other special, incidental or consequential damages caused by the use, misuse or inability to use SOFTWARE, whether on account of negligence or otherwise, or by failure to confirm to any express or implied warranties or conditions (some States or Provinces do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you).

The disclaimers and limitations set forth above will apply regardless of whether LICENSEE accepts the Software. This limited warranty gives legal rights, and you may also have rights, which vary, from country to country.

6. Severability: In the event that any of the provisions of this Agreement shall be held by a court or other tribunal of component jurisdiction to be unenforceable, the remaining portions of this Agreement shall remain in full force and effect.

7. Acknowledgment: By using SOFTWARE, LICENSEE acknowledges that they have read this Agreement, understand it, and agree to be bound by its terms and conditions. LICENSEE also agrees that this Agreement is the complete and exclusive statement of Agreement between the parties and supersedes all proposals or prior Agreements, verbal or written, and any other communications between the parties relating to the subject matter of this Agreement. No amendment to this Agreement shall be effective unless signed by an authorized officer of LICENSOR.

8. Modifications to Agreement: This Agreement will be governed by the laws of the Commonwealth of Virginia. This Agreement may only be modified by a license addendum which accompanies this license or by a written document which has been signed by both LICENSEE and LICENSOR.
